FOBA purpose: To bring people together and enhance our neighborhood.

Chain Link Project Update

The chain link fence beautification project FOBA was considering was a proposal to insert digitally printed plastic slats in to the existing chain link fences that borders the stretch of SFPUC land on 18th Avenue at Bay and 14th Avenue at Athlone Way. This would create the appearance of a mural and soften the industrial look of the chain link. SFPUC granted tentative approval of the project after discussion of maintenance responsibility including repair and graffiti abatement. A survey was sent to neighbors within the N2N boundaries and a description of the project was posted on NextDoor North Fair Oaks to gather opinions on the proposal. The collected data showed there was not resounding support either way, but there were many comments from neighbors who opposed the slats and felt they were artificial, cheap-looking, prone to graffiti, and generally detracted from the open space feeling of the neighborhood. After further discussion, an affirmative vote by the FOBA Board was taken to cancel the slat insertion project. There were suggestions to try painting the fence but professional fencing companies that were contacted stated paint needed to be applied as a powder coating during manufacture and attempts to paint after installation would be prone to immediate chipping. Suggestions were also received to plant wildflowers in the corridor, but as the land is owned by the SFPUC, this could be considered trespassing. Also the lack of irrigation and the annual process of hydro seeding will minimize the chances of any wildflower development. The fences cannot be removed per the SFPUC as they are necessary for security.

Triangle Mini-Park

The triangle space at 9th Avenue, Fair Oaks, and Edison Way is being discussed to restore the lot that declined during the Hetch Hetchy pipeline upgrade due to lack of water. Janet Bell, landscape contractor and NFO resident, is working on a design plan to take advantage of existing trees and shrubbery, while incorporating native plants and maintaining an open feel and line of sight for vehicles and pedestrians. Final designs will be voted on at an upcoming FOBA meeting.

Parks Make Healthy Communities

I'm pleased to report that the County's 91year tradition of maintaining large-scale regional parks and trails may be about to change! Supervisor Don Horsley and I represent districts with communities that want and need smaller neighborhood parks and green spaces to promote health and wellbeing. We asked the Parks Department and the Parks Commission to see what policy change would be feasible for the County. A proposed new Mini-Parks Policy for the unincorporated areas will, if adopted by the Board of Supervisors, authorize the Parks Department to partner with organizations such as FOBA to create and maintain mini-parks in the unincorporated areas of the county. It will support the County's strategic goal of building "Healthy Communities" as well. And, miniparks like the FOBA Pocket Park and Friendship Park in North Fair Oaks and Quarry Park, Moss Beach Park and Clipper Ridge Community Park on the coast would gain partial support and a legitimate "home" in our family of parks, fitting within the Parks Department's mission.
